PURPOSE OF THIS FORM: The purpose of the notification of intent to re-enroll should be used for students who:

1. Exited the college through an approved request for leave who plan to re-enroll within one (1) calendar year of the last term of enrollment.
2. Exited the college because of academic suspension.

The deadline for submission of this form is five weeks before the first day of the term of your anticipated return.

You should NOT complete this form if you:

1. Have not been enrolled at the college for more than one (1) calendar year. An Application for Readmission must be completed and submitted to the Office of the Registrar for review and consideration.
2. Exited Antioch College because of academic dismissal. Contact the registrar to find out if you may be eligible for return.
